Third Amended Complaint, filed as Exhibit A to Plaintiffs' Motion for Leave to File Third
Amended Complaint, filed with this Court on June 7, 2010.

Moreover, during the long period of time that the DVA has been involved in **240.** 5 deciding whether affected veterans obtain free, priority health care and SCDDC, as well as 6 conducting the outreach activities described above, the DVA has been conducting its own 7 experiments using human subjects (veterans) that involve many of the same chemical and 8 9 biological weapons that were the subject of the Army and CIA programs, and many of which also failed to comply with the Official Directives. For example, the DVA has tested LSD-25 on 10 veterans dating back to at least the late 1950s. The DVA also conducted studies at its own 11 medical facilities in the early 1960s using veterans residing at a VA domiciliary as guinea pigs, 12 which were sponsored by the CIA and used CIA cut-outs for funding; for example MKULTRA 13 Subproject 125, conducted at the VA Center in Martinsburg, West Virginia, involved studies of 14 differential effects of drugs such as meprobamate and dextro-amphetamine on behavior, including 15 the placebo effect, utilized unwitting subjects, and used the Society for the Investigation of 16 Human Ecology as a cover for funding and security purposes. Based upon recent VHA filings 17 concerning its Research Laboratory Hazardous Agents Control Program, the common 18 19 chemicals/drugs tested by the DVA and the other Defendants include BZ (3-quinuclidiny) benzialate), Lewisite, LSD, mustard gas, phosgene, sarin, soman (GD), tabun (GA), VX (nerve 20 gas), and others. Tests conducted in VHA research facilities also include a long litany of 21 biological agents such has botulism, anthrax, ebola virus, brucella, and many others. 22 23
